## ERA Efforts on Hold for League

In July 2009, the AAUW NC Board approved a resolution to support the League of Women Voters' effort to educate citizens in NC about the ERA and the need to pass the legislation in NC.

In June 2010 the State LWV Council agreed to temporarily postpone the idea! of working as a lead organization to muster support for the ERA in NC at this time.!

Some Leagues will continue to pursue educating their own members but the League's work as an umbrella organization, leading other groups such as AAUW in this legislative effort, is temporarily on hold. !

The League is confident that there will be a more appropriate time to launch a coordinated effort to pass the ERA in NC and promises to reestablish a partnership with AAUW NC to that end.

# Wilmington Organizes \$tart \$mart Training

The Wilmington branch, under the leadership of Jean D'Addario, has

organized a training session to train ten new \$tart \$mart facilitators on the UNCW campus in early October. The branch was awarded a \$500 mini grant from AAUW NC to pay the tuition fees of the facilitators. \$tart \$mart Facilitator Training is part of the WAGE (Women Are Getting Even) Project which provides young women who are college juniors and seniors with the tools to negotiate salaries and benefits as they approach the job market.

#### Juvenile Literature Award Selection

Lib Laney, Charlotte and High Country dual member, has been selected as a judge on this year's panel that will select the Juvenile Literature Award winner. The award has been given by AAUW NC for several years, as part of the NC Literary and Historical Association programs. The award will be presented at the Association's annual meeting on November 12 in Raleigh.

## High Point Branch Disbands

The High Point branch officially disbanded in September. Though the branch had fifteen members, no one was willing to assume any leadership positions. The branch disbursed its assets by awarding \$1000 to the Legal Advocacy Fund (LAF) and \$3000 to the Ann Chipley Fund.

## Public Policy Initiatives

Given that we do not have a full complement of elected state officers, any recommendations to endorse legislation as a state organization will be forwarded to the Board for a decision. Most of these endorsements are timely requests; in these instances the Board will vote electronically, by mail or by phone, rather than trying to meet in person.
