# Board Minutes of April 20, 2007

A motion to amend the minutes of the April 20, 2007 Board Meeting in Winston Salem to move Mary Peterson, Advocacy Chair, to the list of Board members present was offered, seconded and approved. The motion to approve the April 20, 2007 minutes as amended was offered, seconded and approved.

# Treasurer's Report

Net income at the close of this fiscal year on June 30, 2007 was \$803.51. Nancy noted that AAUW NC operated in the black, thanks to the fund raising activities at convention especially. The Tar Heel News came in under budget.

The Annual Financial Statement was accepted as presented in DRAFT form. Once the statement is reviewed by an outside party, the statement will be published officially for the membership.

## 2007-2008 Budget

The budget which was presented was very similar to the budget tentatively adopted at convention in April 2007. \$1200 is available as mini-grants to branches, Nancy called attention to an allocation for note-taking at convention in 2008. The budget shows a convention profit of \$500 and \$2200 anticipated income from fundraising activities.

Group expenses are allocated to support the work of the teams/committees and may include travel, printing, telephone, etc. expenses.

The motion to approve the budget as recommended by the Executive Committee was seconded and approved. A copy of the budget will be printed in the next issue of the Tar Heel News.

#### New Business

There remains a fifth vacancy on the Nominating Committee which the Executive Committee is authorized to fill.

Becky Hamrick from the Gaston Regional Branch agreed to fill the slot of Parliamentarian on the Board. Nancy made this appointment with the approval of the Executive Committee members in attendance.

#### Branch Recognition

Barbara White announced the recognition awards for ten branches who completed the recognition forms distributed earlier in the year. Charlotte received a silver award; Gaston Regional was awarded gold status. The following branches received platinum honors: Brevard, Chapel Hill, Greensboro, Raleigh/Wake, Sandhills/Southern Pines, Tryon Area, Twin Rivers/New Bern and Wilmington.

Barbara welcomed any suggestions for improving the recognition process currently being used for AAUW NC branches.

#### NC Conference for Women in Charlotte

Barbara announced the date of the conference (October 30, 2007) and distributed flyers about the NC Conference for Women in Charlotte. AAUW NC will have a booth at the convention. Registration is \$150 per person. Scholarships are available for registration through the mini grant program.

The convention will not conflict with the next AAUW NC Board meeting which will be held in High Point on October 19-20, 2007.

## **AAUW Historical Dates**

Nancy distributed various pages of historical information to those attending the Board meeting. The information marked positions and dates which AAUW has taken over the decades to advance equity for women and girls. Later in the meeting each table was asked to select just one bit of information and comment briefly on why this historical item was selected for its historical significance.

## April Convention "Winners"

Based on the names of those who returned surveys at the end of convention in Winston Salem in April, two winners were announced from a random drawing of these names. Jo Gilbert from Sandhills/Southern Pines will receive a free registration for convention in 2008. Virginia Palmer from Statesville will get a refund of her registration fee for this year's convention.

#### Miscellaneous Announcements

The deadline for the next issue of the Tar Heel News is August 3, with an anticipated mailing date of August 31. The paper will include a new feature, a "forum," wherein members can offer comments, opinions, ideas, etc. on various subjects.

Nancy announced that the following members were appointed by the Executive Committee to the AAUW NC Board: Connie Ochse as Communications Chair, Marty Folsom as Newsletter Editor, Pat Tilley as Chair of the Nominating Committee, Judy Atkinson as Team Building Liaison on the Administrative Committee and Sue Mengert, Co Chair of Convention and member of the Events/Program Committee.

Mary Fran commented that reimbursement forms for Board members for attendance at this board meeting were available on the web and should be sent to her.

Mary Peterson offered congratulations on legislative progress on same-day voter registration, mental health parity and college cost reduction issues.

AAUW NC history books are available to any branch which does not have a copy in its files.

Lou Dean Howard asked about the possibility of sending the newsletter as a PDF who any member who requested this format. Marty responded that a PDF version of the newsletter is always available on our web site, and that record keeping for who gets what format of the newsletter was too hard to manage at this time.

Queen Thompson plans to redistribute the Diversity Survey again this fall, since an earlier return from the branches was poor.

The meeting was adjourned at 10:01 AM.
